### **ATTENTION APPLICANTS**

Please mail your NGM application/supporting documents to Newe-Numa Resource Program, P.O. Box 219, Owyhee, NV 89832. Must be postmarked by 6/17/20. Incomplete applications will not be accepted!

**The following required documents must be submitted with your NGM application in order for your application to be complete:**

1. Must have **three forms** of identification which are **Tribal ID, current Owyhee Combined School Student ID, and Social Security card.**
2. Must **fully** complete NV Gold Mines Summer Youth Application. Must include: signature, date, address and reliable contact numbers.
3. Current Owyhee Combined School attendance record (full school yr).

Eligibility Requirements as per Summer Youth Program Employee Handbook [pg 2(I. A-D)] states:

- A. Recognized to be an enrolled member of a federally recognized Indian Tribe, eligible for enrollment or be able to establish descendency from a Tribe.
- B. Must be between 14 thru 18 years of age.
- C. Must be a student at Owyhee Combined Schools or recently graduated senior from Owyhee High School.
- D. Must be a Duck Valley Indian Reservation Community resident.

It is the responsibility of the applicant to make sure all required documentation and documents for proof of eligibility requirements are attached to their application. If there are any questions please ask the NNRP Staff.
