

ORDINANCE NUMBER 2010-SPO-05

BE IT ENACTED BY THE GOVERNING BODY OF THE SHOSHONE-PAIUTE TRIBES OF THE DUCK VALLEY INDIAN RESERVATION, THAT

In accordance with Article VI, Section 1(k) and (l) and (s) of the Constitution of the Shoshone-Paiute Tribes of the Duck Valley Indian Reservation, the Tribal Business Council hereby enacts this Ordinance to the Law and Order Code known as the "Duck Valley Reservation Fishing and Hunting Ordinance," which Ordinance shall be effective upon passage.

WHEREAS, The Shoshone-Paiute Tribes (SPT) is very concerned about regulating its hunting and fishing on the Duck Valley Indian Reservation;

NOW THEREFORE BE IT ENACTED BY THE SHOSHONE-PAIUTE BUSINESS COUNCIL OF THE SHOSHONE-PAIUTE TRIBES THAT, the adoption of this Ordinance rescinds the previous Ordinance in its entirety: 2003-SPO-06 Duck Valley Tribal Hunting and Fishing Ordinance;

BE IT FURTHER RESOLVED THAT, in the Law and Order Code, as enacted, this amended "Duck Valley Reservation Hunting and Fishing Ordinance," is added, which Ordinance shall govern the hunting, fishing, trapping, and camping on the Duck Valley Indian Reservation, Idaho/Nevada, and is herewith duly adopted and approved.

SECTION 1-TITLE

This Ordinance shall be known as the Duck Valley Reservation Hunting and Fishing Ordinance.

SECTION 2-JURISDICTION

- a. This Ordinance shall be criminally applicable to all Tribal Members of the Shoshone-Paiute Tribes, all persons enrolled in or eligible to be enrolled in a federally recognized Indian tribe, and civilly applicable to Non-Indians.
- b. No act prohibited by this Ordinance shall be committed by any member or non-member of the Shoshone-Paiute Tribes, on the Duck Valley Indian Reservation even though such act would be lawful under the laws of the states of Nevada or Idaho.

SECTION 3-DEFINITIONS

- a. Animals, birds, and fish as used herein shall mean any animals, birds, or fish which are not domesticated
- b. "Bag Limit" means the maximum number of animals, birds, or fish which may be taken, caught, killed or possessed by any member or non-member of the Shoshone-Paiute Tribes or any non-Indian on the DVIR as specified by relation of time, date, or so specified and fixed as to size, sex, or species
- c. "Closed Area" means any place, river or stream described or designated by regulation of the Shoshone-Paiute Business Council wherein it shall be unlawful to hunt, fish, or trap for animals or birds.
- d. "Closed Season" means all of the time during the entire year excepting the "Open Season" as specified by regulations of the Duck Valley Business Council.
- e. "Fish and its' derivatives, "fishing", "fished", etc., means any effort made to kill, injure, capture, or catch a fish.
- f. "Hunt" and its' derivatives, "hunting", "hunted", etc., and "trap" and its' derivatives, "trapping", trapped", etc., means any effort to kill, injure, or capture a wild animal or wild bird.
- g. "Members of the Shoshone-Paiute Tribes" shall mean any person who is an enrolled member of the Shoshone-Paiute Tribes.
- h. "Non-Members" shall mean any person, Indian or Non-Indian who is not an enrolled member of the Shoshone-Paiute Tribes.

- i. "Open Season" means the time and dates specified by regulations of the Shoshone-Paiute Tribes when it shall be lawful to hunt, trap, or fish for specified animals, birds, or fish. Each period of time specified as an open season shall include the first and last day thereof.
- j. "Tribal Court" means the Shoshone-Paiute Tribal civil or criminal court. Duck Valley hunting, fishing, trapping, and camping permits shall contain the following: "By execution of a Tribal hunting, fishing, trapping, and/or camping permit, the applicant acknowledges and voluntarily consents to civil or criminal adjudication in the Shoshone-Paiute Tribal Court, for any infractions of the Duck Valley Hunting and Fishing Ordinance No. 2010-SPO-05, and existing Federal Statutes, or State Statutes.
- k. "Law Enforcement Officer" means Bureau of Indian Affairs police officer and any Shoshone-Paiute Tribal Game Protector or Warden, employed by the Shoshone-Paiute Tribes, to enforce the Duck Valley Hunting & Fishing Ordinance on the Duck Valley Indian Reservation.
- "Duck Valley Indian Reservation" means the Duck Valley Indian Reservation as set forth in the Constitution and By-Laws of the Shoshone-Paiute Tribes of the Duck Valley Reservation, Idaho/Nevada.
- m. "Antlered Deer" means any deer with antlers.
- n. "Antlerless Deer" means any deer without antlers or with antlers shorter than their ears.
- o. "Civil" means not a criminal offense, and pertains to the jurisdiction exercised by the Shoshone-Paiute Tribes of the Duck Valley Indian Reservation.
- p. "Civil citation" indicates every lawsuit being brought, other than a criminal proceeding, which the Shoshone-Paiute Tribes bring to enforce a right or collect payment for a violation not involving government prosecution.
- q. "Criminal" means, in this ordinance, having to do with the Tribal Law of crimes and illegal conduct, committed by Members of the Shoshone-Paiute Tribes or persons enrolled in or eligible to be enrolled in a federally recognized Indian tribe.
- r. "Criminal citation" indicates the procedure by which a Shoshone-Paiute Tribal Member accused of a crime is brought to trial and given punishment or fine, if that person pleads guilty or is found guilty of the crime.
- s. "Attachment bond" means money, or property that has been put up to free property that has been attached. The bond substitutes for the property and guarantees that the person who attached it wins in court; there will be money to pay the claim.

- t. "Attachment" is the act of taking or seizing property or persons in order to bring them under the control of the Shoshone-Paiute Tribal Court. For example, a piece of property may be "attached" in order to make sure that a person pays a debt that might result from a successful lawsuit.
- u. "Immediate family" means spouse/guardian and children under the age of 18.
- v. "Traditional Practices" refers to hunting customs and tradition as it relates to the hunting seasons for wildlife.
- w. "Fishing" The activity of catching, taking, capturing, killing, or crippling fish and attempts to do so.
- x. "Artificial Lure" Any device w/hook(s) attached, made partly or entirely of wood, metal, rubber, plastic, or feathers.
- y. "Artificial Fly" Any device of one hook typically used in the activity of flyfishing made partly or entirely of feathers, thread, fur, hair, cloth, wire, or other decorative materials.
- z. "Live bait" Any living organism or substance used to attract fish (earthworms are excluded from this definition).
- aa. "Chumming" The placement of any material or organisms which fish may feed in order to attract fish to a particular location.
- bb. "Household" all those living in one house.
- cc. "Big Game" consists of deer, elk, and antelope.

SECTION 4—REGULATIONS OF HUNTING AND FISHING

- a. The Shoshone-Paiute Business Council shall promulgate such regulations as it deems necessary and proper to regulate hunting, fishing, trapping, and camping on the DVIR. Such regulations may establish closed or open areas, closed or open seasons, bag limits, gear restrictions and any other provisions necessary to carry out the provisions of the Ordinance.
- b. All duly approved fishing, hunting, trapping, and camping regulations of the SPT shall be communicated to the general public as widely as possible, including providing information with respect to such regulations to newspapers, magazines and any other publications which are likely to bring such news to the attention of Tribal Members and general public, posting notices as to such regulations wherever possible on the DVIR, and in adjoining communities, and making copies of such regulations available to the general public.

SECTION 5—REGULATIONS FOR MEMBERS OF THE DUCK VALLEY INDIAN RESERVATION OF THE SHOSHONE-PAIUTE TRIBES

5.1 HUNTING/TRAPPING

Tribal members are required to obtain a hunting permit for big game and a trapping permit for the following animals: bobcat, coyote, mountain lion, and beaver*. Permits are available at no cost at the Fish, Wildlife and Parks Department. Tribal members are required to carry a valid and updated Tribal Enrollment Card on their person and to present such card to the proper authorities upon request.

- a. Tribal Members shall be entitled to harvest one antlered buck mule deer per tribal member.
- b. Female mule deer (doe) may not be killed or possessed on the Duck Valley Indian Reservation, unless allowed periodically by tribal resolution.
- c. Tribal Members may kill or possess antelope for their subsistence on the DVIR during hunting season only.
- d. Tribal Members may kill or possess one (1) elk (male or female) per household per year.
- e. It shall be unlawful for a non-member of the Shoshone-Paiute Tribes to accompany a tribal member on a hunt.
- f. Hunting season is set from August 15th through November 30th for big game.
- g. Hunting for animals such as groundhog, rabbits (except pygmy rabbits), and squirrels will follow traditional practices.
- h. The Shoshone-Paiute Business Council may further limit hunting on the DVIR by enrolled members in certain locations on the Reservation for specific periods when necessary to protect and enhance a particular species.
- i. Tribal elders, disabled tribal members, and female head of households may designate a tribal member to harvest big game for them but are still required to obtain a hunting permit from the Fish, Wildlife and Parks Department and to designate the tribal hunter's name on the permit.
- j. * A trapping permit is not required for controlling nuisance beavers, badgers, or coyotes.
- k. Trapping Season Dates are from October 1-March 31
- Tribal members may not hunt or kill non-game birds such as hawks, eagles, songbirds (meadowlarks, sparrows, etc.). Tribal members may hunt ducks, geese, chukar, ruffed grouse and other game birds.

- m. The hunting/trapping season is closed for the following species: bighorn sheep, moose, and pygmy rabbit.
- n. Federally listed threatened or endangered species may not be hunted or trapped.
- o. Tribal members that have been designated to hunt for an elder, disabled, or female head of household may only hunt for a total of 2 people (in addition to themselves).
- p. Tribal members shooting coyotes for pelts must obtain a trapping permit.
- q. The Shoshone-Paiute Business Council, at their discretion, may issue big game permits for ceremonial purposes, special events, or in response to a special request from a tribal member.

5.2 FISHING

Only enrolled members of the Shoshone-Paiute Tribes of the Duck Valley Reservation may fish on the DVIR without first obtaining a permit or license. Tribal members are required to carry a valid and updated Tribal Enrollment Card on their person and to present such card to the proper authorities upon request. Tribal members must follow the same fishing rules and regulations as non tribal members with the following exceptions:

- a. Tribal Members may fish year round at Mountain View and Sheep Creek Reservoirs. Lake Billy Shaw is open from April 1- October 31.
- b. Fishing shall be only for subsistence or recreation purposes.
- c. Daily possession and limit shall be:
 - i. Mountain View/Sheep Creek- 10 fish, either Trout, Charr or Whitefish.
 - ii. No limit on perch or bass
- d. The Shoshone-Paiute Business Council, by special resolution, may further limit fishing on the Duck Valley Indian Reservation by enrolled members in certain locations on the Reservation for specific periods when necessary to protect and enhance a particular species.

5.3 CAMPING

Only enrolled members of the Shoshone-Paiute Tribes of the Duck Valley Reservation may dry camp at no charge on the DVIR without first obtaining a permit. Tribal members are required to carry a valid and updated Tribal Enrollment Card on their person and to present such card to the proper authorities upon request.

- a. Use of electrical sites is allowed at a reduced rate.
- b. Reservations for electrical sites must be made through "Our Store".

SECTION 6-CIVIL REGULATIONS FOR NON-MEMBERS

6.1 HUNTING

Hunting opportunities for non-members are limited to guided Antelope hunts.

- a. Non Tribal member hunt dates are July 15-Oct 31.
- b. It shall be unlawful for a non-member of the Shoshone-Paiute Tribes to accompany a tribal member on a hunt.
- c. Hunting permits or licenses shall be issued only for antelope.
- d. Hunters must have valid proof of payment from the Shoshone-Paiute Tribes prior to the start of the guided hunt.
- e. All guided hunts must be coordinated by Shoshone-Paiute Tribes' Fish, Wildlife and Parks Department.
- f. Children must be at least 12 years of age to hunt and must be accompanied by an adult (18 years or older). Youth hunts are only offered in conjunction with an adult hunt.
- g. A "Tribal Permit to Transport" must be filled out by a Fish Wildlife and Parks personnel appointed by the Director before carcass can leave the reservation.
- h. Fish, Wildlife and Parks Department, with approval of the Tribal Administrator, will establish hunting rates for guided antelope hunts for non members
- i. A valid Tribal hunting permit must be in possession before discharging a firearm on the Duck Valley Indian Reservation.
- j. Any hunter harvesting an antelope must present the head, hide, and edible portion of the carcass of the animal to the Fish, Wildlife & Parks Department for inspection within 48 hours of killing the animal.
- k. Hunting antelope may be done with a bow & arrow, black powder, or center fire rifle.
- The Shoshone-Paiute Business Council will establish the closed or open areas, open season, and gear restrictions, etc., for the hunting of antelope by non-members on the Duck Valley Indian Reservation.

6.2 FISHING

The following non-member fishing and camping regulations are hereby adopted:

a. Open waters: Mountain View Reservoir; Sheep Creek Reservoir; Lake Billy Shaw and the East Fork of the Owyhee River upstream from the China Diversion Dam to the Reservation

boundary. Tributaries of the East Fork of the Owyhee River are not open to the public for fishing.

- b. Season: The waters listed above will be open to non-members from April 1 through October 31, excluding Mountain View Reservoir which will be open for fishing year round.
- c. Daily possession and limit: five (5) trout daily, ten (10) in possession for adults; four (4) trout daily, eight (8) in possession for children. (no limit on non-salmonid species)
- d. Fishing hours: Two (2) hours before sunrise until one (1) hour after sunset.
- e. Tackle: A two (2) rod/pole is allowable with purchase of appropriate daily fishing permit per individual. Other approved tackle/gear is listed as line, reel, artificial lures, artificial flies, artificial baits, earthworms, corn, salmon eggs, single or treble hooks, bobbers, and weights. Prohibited tackle/gear includes any live bait (with exception of earth worms) chumming bait, firearms, bows, or any other gear not commonly used in angling.
- f. The possession of live bait is prohibited while fishing waters of the Duck Valley Indian Reservation.
- g. Boating: Will be allowable for fishing purposes only, no speeding in water, no jet skiing, no water skiing, no littering of waters.
- h. Special fishing regulations for Billy Shaw: anglers may keep one trout between 16 inches and 19 inches in length. Any trout outside this range must be released unharmed back into the water. Only electrically powered boats are allowed. Anglers may only use artificial flies with a single barbless hook. One dropper is allowed.
- i. No reservoir inlet will be open for fishing
- j. The Shoshone-Paiute Business Council, by special resolution, may further limit fishing on the DVIR in certain locations for specific periods when necessary to protect and enhance a particular species.

6.3 CAMPING

- a. Overnight Camping: Allowable in designated camping areas only with appropriate permit. Campers are limited to stay fourteen (14) continuous days, unless approved by Fish, Wildlife and Parks Department.
- b. Campfires: Campfires are allowed only in designated areas and in properly secured pits. All fires and cigarettes must be carefully extinguished. Campfires and other sources of ignition can be banned at the discretion of the Shoshone-Paiute Fire Department, check information board at the entrance of each reservoir for status.

- c. Littering: Around campsites, reservoirs, rivers, roadsides, is strictly prohibited.
- d. Destruction of Property: Defacing of signs, camping facilities, fences, and rest rooms is strictly prohibited.
- e. Discharging a firearm is prohibited
- f. ATV's and all motor vehicles may be operated on maintained roads and two tracks within the campground and dam areas. The speed limit in these areas is 3 mph
- g. Fireworks are prohibited at all reservoirs.
- h. Camping permits for electrical sites must be reserved through and picked up at "Our Store."

SECTION 7-PERMIT TO TRANSPORT FISH AND GAME

7.1 TRANSPORTING GAME

- a. Fish and game taken pursuant to this ordinance must be killed or caught within the boundaries of the Duck Valley Indian Reservation.
- b. Fish and game shall only be taken for subsistence.
- c. Enrolled members shall not sell fish or game taken off the reservation. Enrolled members shall not give fish or game to non-members off the reservation.
- d. All Fish and Game leaving the reservation must have a Permit to Transport permit, with exception of persons holding a fishing permit.
- e. The Business Council, by special resolution, may further limit hunting and fishing on the reservation by enrolled members in certain locations on the reservation for specific periods when necessary to protect and enhance a particular species. Enrolled member will be expected to become familiar with such special ordinances and should check at the Tribal Office before hunting and fishing to determine if any locations have been closed.
- f. The Fish, Wildlife and Parks Department are given authority to prepare and issue a Permit to Transport Fish and Game. The permit shall contain the name of the hunter, tribal enrollment number, address, phone number, type and number of fish or game taken, sex of game taken, date that the fish or gave was taken, location that the fish or game was taken, and the name and title of the person inspecting the fish or game and the date the fish or game was inspected. A valid permit is one that contains the tribes' name, address, phone number, tribal logo affixed to the permit, and the signature of an authorized staff member of the Tribal Fish, Wildlife and Parks Department.

- g. Fish or game shall not be removed from the Duck Valley Reservation, unless fish or game is inspected, a Permit to Transport Fish and Game has been properly filled out, signed by an authorized Fish, Wildlife & Parks Department employee and permit holder and the permit affixed to the fish or game.
- h. Enrolled members shall carry their tribal identification card while transporting fish or game off the reservation and keep the Permit to Transport Fish and Game attached to the fish or game until they reach their destination.

7.2 COOPERATION WITH STATE AUTHORITIES

- a. Enrolled members of the Shoshone-Paiute Tribes shall fully cooperate with state authorities when transporting fish or game off the reservation and shall stop at all game inspection stations or at any other time requested by proper authorities and shall show their tribal identification card, Permit to Transport Fish and Game, permit inspection of the fish and game and answer questions concerning the fish and game.
- b. The Tribal Chairman or Administrator shall provide Idaho and Nevada Fish and Game authorities with the information recorded by the Fish, Wildlife and Parks Department concerning fish and game upon request.
- c. The Tribal Chairman or Administrator shall contact the Idaho and Nevada Fish and Game if the Permit to Transport Fish and Game is altered or if the ordinance is amended.
- d. The Tribal Chairman or Administrator shall provide the Idaho and Nevada Fish and Game authorities with copies of any special resolutions further restricting fish and game during certain periods upon request.

7.3 VIOLATION

a. Any violation of this ordinance by an enrolled member shall be a gross misdemeanor to be enforced by the Shoshone-Paiute Tribal Court. The Tribe may seek extradition if the enrolled member is located off the reservation. Upon conviction, the enrolled member may be punished by the fine not to exceed \$500.00 and/or by sentence up to 6 (six) months in jail. The court may also suspend the member's tribal hunting and/or fishing privileges for a specified period or, upon repeated violations, permanently. When the Court revokes or suspends hunting privileges, it may mark the tribal identification card to indicate the limitation and shall notify the Tribal Administrator of the limitations imposed

SECTION 8-CONSULTATION WITH STATE AND FEDERAL AGENCIES

- a. Copies of this Ordinance shall be made available to applicable Governments of the States of Idaho and Nevada, and Federal agencies
- b. Notices of all meetings pertaining to this Ordinance shall be sent to the State and Federal agencies and other respective governments whenever it is deemed necessary. For consultation

and technical assistance, the Tribes may invite Idaho Department of Fish and Game, Nevada Division of Wildlife, Bureau of Indian Affairs, or any other respective agencies to be present during meetings.

SECTION 9—PROHIBITED ACTS

- a. It shall be unlawful for any member or non-member of the Shoshone-Paiute Tribes, to hunt, fish, camp or trap during closed season(s). It shall also be unlawful for any member or non-member of the Tribes, to kill, take, or catch any species of birds, animals, or fish in excess of number fixed as the specified limit. It shall also be illegal for any member, or non-member to hunt, trap, or fish within the boundaries of any closed area on the DVIR.
- b. It shall be unlawful for a non-member of the Shoshone-Paiute Tribes to accompany a tribal member on a hunt.
- c. It shall be unlawful for any member or non-member to have in his/her possession or under his/her control any bird, animal or fish during the closed season, or in excess of the specified limit.
- d. It shall be unlawful to hunt with firearms while under the influence of alcohol or drugs.
- e. It shall be unlawful for any non-member to camp or fish on the DVIR without first obtaining a permit.
- f. It shall be unlawful to permit any animal, bird, or fish needlessly to go to waste after killing the game (wanton waste).
- g. It shall be unlawful to resist or obstruct a Law Enforcement Officer in the discharge of his/her duties while enforcing the provisions of this Ordinance, or other Tribal regulations governing hunting, fishing, trapping or camping on the DVIR.
- h. It shall be unlawful to destroy, tear down, shoot at, deface or erase any printed matter or signs placed or posted by or under the instructions of the Shoshone-Paiute Tribes.
- i. It shall be unlawful to shoot domestic livestock while hunting, fishing, trapping or camping on the DVIR.
- j. It shall be unlawful for any non-member to kill, take, catch, trap or fish for animals, birds or fish without first acquiring and possessing the proper Tribal permit.
- k. It shall be unlawful to hunt during the period extending from 1/2 hour after sunset to 1/2 hour before sunrise.
- 1. It shall be unlawful to spot-light (jack lighting) hunt on the DVIR.

- m. All game other than antelope are illegal to hunt by non-members at any time.
- n. It shall be unlawful to harass wildlife with a motor vehicle.
- o. It shall be unlawful to trap/hunt/kill/harass beaver on any lands designated as rangeland.
- p. It is unlawful to transport any wildlife off the reservation without first obtaining a permit to transport from the Fish, Wildlife and Parks Department.
- q. It shall be unlawful to hunt big game or trap designated species without first obtaining a permit.
- r. It shall unlawful to hunt/kill big horn sheep or moose.
- s. It shall be unlawful to hunt/kill pygmy rabbits.
- t. It shall be unlawful to hunt or kill non-game birds.

SECTION 10—ENFORCEMENT

- a. It shall be the duty and responsibility of Law Enforcement Officer(s) to enforce rules and regulations adopted and approved by the Shoshone-Paiute Business Council; and such Law Enforcement Officer(s) may issue civil of criminal citations and/or take into custody any member of the Tribes violating the criminal laws or regulation, or non-member violating the civil laws or regulations of the Shoshone-Paiute Tribes of the DVIR.
- b. Any Shoshone-Paiute Tribal Game Protector or Warden may without warrant, arrest any Tribal Member or person/persons enrolled in or eligible to be enrolled in a federally recognized Indian tribe, or civilly detain any non-Indian found violating any regulation of the Duck Valley Hunting and Fishing Ordinance.
- c. Any Shoshone-Paiute Tribal Game Protector or Warden may, upon a showing of probable cause to believe there is evidence of regulation violations of this ordinance, through the issuance of a search warrant by the Shoshone-Paiute Tribal Court search any conveyance, vehicle, game bag, game basket, game coat, or other similar place which he/she believes contains such said evidence.
- d. Any Law Enforcement Officer may seize without warrant all birds, animals, fish or parts thereof taken, killed, transported or possessed contrary to this Ordinance, or any regulations of the SPT of the DVIR pertaining to hunting, fishing or trapping; and any dog, gun trap, net seine, decoy, bait, boat, light, fishing tackle or other device unlawfully used in hunting, fishing, or trapping, or held with intent to use unlawfully in hunting, fishing or trapping. Anything seized pursuant to subsection (d) of this section shall be subject to forfeiture at the order of the Shoshone-Paiute Tribal Court after notice and opportunity for civil or criminal

hearing or trial as hereafter set forth. In case it appears upon the sworn complaint of the Officer making the seizure that any article(s) seized were not in the possession of any person and that the owner thereof is known, the Tribal Court shall have power and jurisdiction to forfeit such article(s) upon hearing duly after service of summons on the unknown owner by publishing such summons in any newspaper of general circulation in the counties surrounding the DVIR for a period of four (4) successive weeks. Said summons shall describe the article(s) seized and shall give the owner 15 days from the date of last publication to appear before the Tribal Court and contest the forfeiture.

- e. Anything seized pursuant to subsection (d) of this section shall be subject to forfeiture at the order of the Shoshone-Paiute Tribal Court after notice and opportunity for civil or criminal hearing or trial as hereafter set forth. In case it appears upon the sworn complaint of the Officer making the seizure than any article(s) seized were not in the possession of any person and that the owner thereof is unknown, the Tribal Court shall have power and jurisdiction to forfeit such article(s) upon hearing duly after service of summons on the unknown owner by publishing such summons in any newspaper of general circulation in the counties surrounding the Duck Valley Indian Reservation for a period of four (4) successive weeks. Said summon shall describe the article(s) seized and shall give the owner 15 days from the date of last publication to appear before the Tribal Court and contest the forfeiture
- f. In the event the Tribal court order forfeiture of any article(s) seized, such article(s) shall be turned over to the Shoshone-Paiute Business Council for the use and benefit of the Duck Valley Tribes. If any article(s) are not declared forfeited by order of the Tribal Court, it shall be returned to the person from who they were seized, after the case has been concluded and fines, if any, have been paid.
- g. The Shoshone-Paiute Tribal Court may, also, upon a showing of probable cause by sworn statement of a Law Enforcement Officer, issue a search warrant and direct a search to be made in any place wherein it is alleged that any bird, animals, or fish, taken or in possession contrary to this Ordinance or regulation of the SPT of the DVIR, is concealed or illegally kept. Such warrant shall authorize the search of any buildings, enclosures of vehicles, and any compartment, chest, box, locker, crate, basket, package, or other receptacle to be opened and the contents thereof examined, provided that the scope of said warrant is limited to the confines of the Duck Valley Indian Reservation.
- h. Any Law Enforcement Officer, in the course of his/her duties, may enter upon any land within the DVIR, and remain thereon while performing such duties without committing a trespass.

SECTION 11-COMPLAINTS & CIVIL VIOLATIONS IN SHOSHONE-PAIUTE TRIBAL COURT

Proceedings brought against any person for violation of any hunting, fishing, trapping or camping of the SPT shall be brought into Tribal Court and initiated by a complaint signed by a Law Enforcement Officer. The complaint shall set forth the following information:

- a. The Shoshone-Paiute Tribal Court.
- b. The name of the person charged.
- c. The offense charged, in the language of the applicable Ordinance provision or regulation, together with a statement as to the time, place, person(s) or property involved as to enable the defendant to understand the character of the offense charged.
- d. If the identity of the person issued the citation is a member of the Shoshone-Paiute Tribes, then the citation shall indicate that the complaint is a criminal complaint. If the identity of the person issued the citation is not a member of the Shoshone-Paiute Tribes, then the citation shall indicate that the complaint is a civil violation for which a fine can be imposed. If the Tribal membership identity of the person issued the citation cannot be determined, then the person shall be issued a civil violation for which a fine can be imposed. However, if law enforcement or the Shoshone-Paiute Tribal Court later learns that a person, who was issued a civil violation for which a fine can be imposed, is a member of the Shoshone-Paiute Tribes, then the Tribes shall re-issue a citation indicating that the complaint is a criminal complaint.

SECTION 12-CITATIONS IN LIEU OF CUSTODY OR CIVIL DETENTION

- a. Whenever a person is criminally arrested or civilly detained for a violation of any hunting or fishing law or regulation of the SPT, the arresting Officer may serve upon the arrested person, a citation and notice to appear in Tribal Court, in lieu of keeping said person in custody or civilly detained.
- b. In determining whether to issue a citation and notice to appear, the Officer may consider the following factors:
 - 1. Whether the person has been properly identified himself/herself satisfactorily.
 - 2. Whether arrest or civil detention appears reasonably necessary to prevent harm to himself/herself or to another, injury to property, or breach of the peace.
 - 3. Whether the person has ties to the community or is a local resident, so to provide reasonable assurance of his/her appearance before the Shoshone Paiute Tribal Court, or whether there is a substantial likelihood that he/she will refuse to respond to the citation; and
 - 4. Whether the person previously has failed to appear in response to a citation issued to this Section, or to other lawful process of the Shoshone-Paiute Tribal Court system.
- c. The citation shall include the name of the person charged, his/her address, his/her date of birth, sex, the date, time, place, and description of the offense charged, the date on which the citation was issued, and the name of the citing Officer. A space shall be provided for the person to sign a promise to appear in the Shoshone-Paiute Tribal Court.

- d. To secure his/her release, the person must give his written promise to appear in the Shoshone-Paiute Tribal Court.
- e. The citation shall state the time and place at which the person is to appear in the Shoshone-Paiute Tribal Court, which shall be not less than 72 hours after the date of the citation, nor more than 15 days after the date of the citation.
- f. The citation when completed by the officer shall serve as the complaint, for the purpose of prosecution in the Shoshone-Paiute Tribal Court, or serve as notice of civil fine violation for litigation in the Shoshone-Paiute Tribal Court.
- g. If a defendant fails to appear, the Shoshone-Paiute Tribal Judge shall issue a Warrant of Arrest, or default judgment, and may order any bail deposited by criminal defendant, forfeited, or execution of civil judgment on property of person who committed a civil violation.
- h. The Tribal Judge shall establish a Bail Schedule for all offenses under the hunting, fishing, trapping or camping laws of the Duck Valley Tribes. Any person criminally arrested and taken into custody or civilly fined for violation of such laws or regulation, may be released upon posting for specified bail or civil attachment bond, with the Clerk of the Tribal Court. This shall not prevent the Shoshone-Paiute Tribal Judge from ordering or authorizing the release of such person(s) without bail or civil attachment bond if he/she is satisfied that such person meets the standard above set forth for reliability as to appearance in Tribal Court for trial, and where such person(s) are without the financial means to post bail, or civil attachment bond.
- i. The Shoshone-Paiute Tribal Judge may also establish a Schedule for Fines for specified violations of the hunting, fishing, trapping and camping laws and regulations of the SPT, which fines may be paid by defendant advising the Tribal Court, either in person by telephone, or in writing that he/she is willing to enter a guilty please, non-member's or non-Indian's property that the Tribes have attached is guaranteed the return of the property if the Tribes lose the civil law suit, or if the non-member pays the appropriate fine. In such cases, NO court appearance shall be required provided the fine is paid prior to the date set for the defendant's trial, or litigant's trial.
- j. When any person is arrested or civilly detained for a violation of the Hunting or Fishing Laws or regulations of the Shoshone-Paiute Tribes or which no bail has been established, such person shall be brought before the Shoshone-Paiute Tribal Judge who may determine whether, and on what conditions the defendant may be released from custody, or pay the fine, pending his/her trial.
- k. In any appearance before the Shoshone-Paiute Tribal Judge upon a charge of violation of any Hunting and Fishing law or regulations of the SPT, the Judge shall cause the defendant or litigant, to be informed of the charge, or civil fine, either in person or with an attorney.

The Judge shall allow the defendant a reasonable time an opportunity to consult an attorney. In criminal cases, the Judge shall also advise the defendant of his/her right to remain silent, and the fact that any statement(s) he/she makes may be used against him/her.

- In any Tribal Court proceeding on a charge of violation of the hunting and fishing laws or regulations of the Shoshone-Paiute Tribes, the Tribes shall prosecute, and/or impose civil fines on, or violation, by the testimony of the Law Enforcement Officer, and any other witnesses called to support the charge(s), or civil violation(s). In presenting such evidence, the Tribe may make use of either a Tribal Official or a licensed Attorney At Law, or a Tribal Court Advocate.
- m. The Shoshone-Paiute Tribal Court shall not be bound by, formal rules of evidence, but shall use its own discretion as to what evidence it deems necessary and relevant to the charge and the defense.
- n. The Shoshone-Paiute Tribal Court require the charge, or violation, to be proven by the greater weight of the evidence, and shall resolve any doubts in favor of the defendant, or the litigant. The defendant, or the litigant, shall be afforded a full opportunity to present his/her defense.

SECTION 13-PENALTIES

Any person pleading guilty or admitting any violation(s) of the Duck Valley Hunting & Fishing Ordinance may be sentenced, or civilly fined, as applicable, to a fine not to exceed \$1,500.00 or other sentences that the Shoshone-Paiute Tribal Court may deem just and fair on a case by case basis.

SECTION 14-LICENSE REQUIRED

- a. All Tribal Members shall carry their Shoshone-Paiute Tribal Enrollment cards on their person when fishing, hunting, trapping, or camping on the Duck Valley Indian Reservation.
- b. No non-member of the Shoshone-Paiute Tribes shall take or possess any fish or wildlife, nor shall they camp without first having procured a Shoshone-Paiute Tribal Hunting, Fishing, or Camping permit, as herein provided and having at the same time such Permit in his/her possession; nor shall any such person lend, sell, give, or assign his/her Permit unless approved by the Shoshone-Paiute Tribal Business Council.
- c. Violation of this Section is punishable as provided in this Ordinance, and other laws and regulations of the Shoshone-Paiute Tribe.
- d. Tribal Member(s) not in possession of their Tribal personal identification card must prove their Tribal Membership within 48 hours, or will be subject to penalty, at the discretion of the Shoshone-Paiute Tribal Judge.



BE IT ENACTED BY THE GOVERNING BODY OF THE SHOSHONE-PAIUTE TRIBES OF THE DUCK VALLEY INDIAN RESERVATION, THAT

In accordance with Article VI, Section 1 (k) and (l) of the Constitution of the Shoshone-Paiute Tribes of the Duck Valley Indian Reservation, the Tribal Business Council hereby enacts this Ordinance to the Law and Order Code, known as the "Duck Valley Chronic Wasting Disease Surveillance Program Ordinance," which Ordinance shall be effective upon passage.

WHEREAS, The Shoshone-Paiute Tribes are concerned about the health and well-being of the Tribal members of Duck Valley Indian Reservation; and

WHEREAS, The Shoshone-Paiute Tribes are concerned about detecting the presence of Chronic Wasting Disease in free ranging deer and elk on the Duck Valley Indian Reservation;

WHEREAS, The Shoshone-Paiute Tribes finds it necessary to establish an Ordinance to ensure the compliance of Tribal members to submit harvested deer and elk for Chronic Wasting Disease Testing;

NOW, THEREFORE BE IT ENACTED BY THE SHOSHONE-PAIUTE BUSINESS COUNCIL OF THE SHOSHONE-PAIUTE TRIBES THAT, In the Law and Order Code, as enacted, this "Duck Valley Chronic Wasting Disease Surveillance Program," is added, which Ordinance shall govern the compliance of Tribal members to submit deer and elk harvested on the Duck Valley Indian Reservation to the Fish, Wildlife and Parks Department for Chronic Wasting Disease testing, and is herewith duly adopted and approved.



Shoshone-Paiute Tribes Ordinance 2009-SPO-01 Page 2 of 4

SECTION 1 – TITLE

This Ordinance shall be known as the Duck Valley Tribal Chronic Wasting Disease Surveillance Program Ordinance.

SECTION 2 - JURISDICTION

- a. This Ordinance shall be criminally applicable to all Tribal Members of the Shoshone-Paiute Tribes.
- b. No act prohibited by the Ordinance shall be committed by any member of the Shoshone-Paiute Tribes, on the Duck Valley Indian Reservation even though such act may be lawful under the laws of the states of Nevada or Idaho.

SECTION 3 - DEFINITIONS

- a. "Chronic Wasting Disease (CWD)" is a fatal neurological disease affecting captive and free ranging mule deer and elk in certain areas of the United States.
- b. "Surveillance Program" refers to the Fish, Wildlife and Parks Department's program to obtain samples from Tribal hunter-harvested mule deer and elk in order to test for CWD. The sampling process involves removing the brain stem from harvested elk and lymph nodes from the head of mule deer and sending the samples in to a laboratory for testing.
- c. "Members of the Shoshone-Paiute Tribes" shall mean any person whose name appears on the records of the Shoshone-Paiute Tribes as an enrolled member of the Shoshone-Paiute Tribes of the Duck Valley Indian Reservation.

SECTION 4 – REGULATIONS FOR MEMBERS OF THE DUCK VALLEY INDIAN RESERVATION OF THE SHOSHONE-PAIUTE TRIBES

- a. Tribal members are required to bring harvested elk and mule deer heads to the Fish, Wildlife and Parks Department so that appropriate samples may be taken by Department staff.
- b. Tribal members are required to bring harvested animals to the Fish, Wildlife and Parks Department within 24 hours of the kill, except during holidays noted below when they may bring animals in the day following the holiday.
- c. Tribal members shall present a Tribal Enrollment Card to the Fish, Wildlife and Parks Department
- d. The Fish, Wildlife and Parks Department will be available 7 days a week through the end of the 2008 hunting season (November 30) to accept deer and elk for sampling (with the exception of November 11 and November 27 in observance of Veterans Day and Thanksgiving Day). Tribal members may bring animals in for testing from 9am 5pm daily.

SECTION 5 - CONSULTATION WITH STATE AND FEDERAL AGENCIES

- a. Copies of this Ordinance shall be made available to applicable Governments of the States of Idaho and Nevada, and Federal agencies.
- b. Notices of meetings pertaining to this Ordinance shall be sent to the State and Federal agencies, and other respective governments whenever it is deemed necessary. For consultation and technical assistance, the Tribes may invite Idaho/Nevada Department of Fish and Game, USDA Animal and Plant Health Inspection Service (APHIS), or any other respective agencies to be present during meetings.

SECTION 6 - PROHIBITED ACTS

a. Failure to comply with the requirement to present harvested deer and elk within 24 hours of killing the animal (except as noted for Veterans Day and Thanksgiving Day) to the Fish, Wildlife and Parks Department for CWD sampling constitutes an unlawful act.

SECTION 7 - ENFORCEMENT

a. It shall be the duty and responsibility of Law Enforcement Officer(s) to enforce rules and regulations adopted and approved by the Shoshone-Paiute Business Council; and such Law Enforcement Officer(s) may issue criminal citations and/or take into custody any member of the Tribes violating the laws or regulations of the Shoshone-Paiute Tribes of the Duck Valley Reservation.

SECTION 8 - CRIMINAL VIOLATIONS IN SHOSHONE-PAIUTE TRIBAL COURT

Proceedings brought against any Tribal member for violation of this ordinance shall be brought into Tribal Court and initiated by a complaint signed by a Law Enforcement Officer. The complaint shall set forth the following information:

- a. The Shoshone-Paiute Tribal Court.
- b. The name of the Tribal member being charged.
- c. The offense charged, in the language of the Ordinance provision or regulation, together with a statement as to the time, place, person(s) or property involved as to enable the defendant to understand the character of the offense charged.
- d. The identity of the Tribal member being criminally charged. If the Tribal membership identity of the person issued the citation cannot be determined, then the person shall be issued a civil violation for which a fine can be imposed under Ordinance 2003-SPO-06, Section 8. However, if law enforcement or the Shoshone-Paiute Tribal Court later learns that a person, who was issued a civil violation for which a fine can be imposed, is a member of the Shoshone-Paiute Tribes, then the Tribes shall reissue a citation indicating that the complaint is a criminal complaint.

SECTION 9 – PENALTIES

Any person pleading guilty or admitting any violation(s) of the Duck Valley Chronic Wasting Disease Surveillance Program may be sentenced to a fine not to exceed \$500.00 per violation or other sentences that the Shoshone-Paiute Tribal Court may deem just and fair on a case by case basis.

SECTION 10 - LICENSE REQUIRED

- a. All Tribal members presenting a deer or elk to the Fish, Wildlife and Parks Department shall present their Shoshone-Paiute Tribal Enrollment Card to Department staff.
- b. Tribal member(s) not in possession of their Tribal personal identification card(s) must prove their Tribal membership within 48 hours, or will be subject to penalty, at the discretion of the Shoshone-Paiute Tribal Judge.

CERTIFICATION

The tribe is hereby notified per copy of this memorandum that in accordance to the duck Valley Shoshon-Paiute Tribal Constitution, Article 4, Section 2. Manner of review; the Western Regional Director has ninety (90) days from the enactment, to review the ordinance and act on it. The ordinance is in effect until such time the Western Regional office rescinds the said ordinance by notifying the Business Council of such decision in writing.
