SPECIAL CONSIDERATIONS:

This position is subject to random drug testing and a background check as a condition of employment. This individual operates Tribal vehicles and equipment on a regular basis. This individual works in hazardous environments (machinery, electricity, chemicals).

IOB SUMMARY:

Under the direct supervision of the Land and Natural Resources Director, the incumbent will be responsible for all equipment operation: Backhoe, Tractor, Off-road vehicles, noxious weed management, pesticides application, brushing, livestock gathering, livestock counting, repairs of Tribal facilities and reservation fences.

SPECIFIC DUTIES:

- 1. Identify, treat, and monitor noxious weeds and invasive plants across the Duck Valley Indian Reservation.
- 2. Safely mix, handle, and apply herbicides, pesticides and other approved weed-control and pest control methods.
- 3. Operate and maintain equipment including ATVs/UTVs, trucks, trailers, tractors and various implements, backhoe, sprayers, and brushers.
- 4. Will see to the proper care of all Tribal Vehicles utilized on the projects, completing services and repairs as needed.
- 5. Responsible for the reporting of progress both verbally and in written form. Collect data, maintain logs, and report daily activities.
- 6. Support fencing, range improvement, and other Natural Resources projects.
- 7. Will perform duties in welding and operation of electric, gas powered equipment and hand tools.
- 8. Assist with livestock management, including: Gathering and moving cattle on horseback/UTV. Checking range units and ensuring livestock remain within permitted areas. Perform Livestock Counts. Providing feed, water, and basic care for livestock when required.
- 9. Will perform other related duties as assigned by the supervisor

MINIMUM QUALIFICATIONS:

- 1. Must have a valid Idaho or Nevada State driver's license (as a policy for insurance purposes, a routine check will be conducted on all drivers for the Shoshone- Paiute Tribes).
- 2. High School Diploma or equivalent preferred. Similar work experience may be substituted.
- 3. Ability to operate heavy equipment, tractors, trucks, and trailers safely.
- 4. Must be physically able to perform all job duties in various conditions and weather.
- 5. Must have successfully completed other projects of a similar nature.
- 6. Experience handling and riding horses for livestock management.
- 7. Able to work during weekends or after-hours, when necessary.
- 8. Must have a "Private Applicator certification" **AND/OR** pass a Private Applicator's Certification Test when it becomes available (required for the handling of restricted pesticides).

PHYSICAL DEMAND:

Incumbent is required to walk in rough terrain, stand, stoop, bend, kneel, climb and work in hot/cold weather conditions. Will be required to setup equipment to perform job duties. Required to lift and carry objects that weigh over 50 to 100 pounds.
