

APPLICATION FOR STANDARD ASSIGNMENT OF LAND (AGRICULTURAL)

I, _____, an enrolled member of the Shoshone Paiute Tribes of the Duck Valley Indian Reservation, hereby apply for Assignment of Land identified as: **TRACT NO.** _____, and described as, _____, Meridian _____, Section _____, Township _____, Range _____, containing _____, acres more or less _____.

This Assignment is made subject to the terms and conditions of the constitution and By-Laws, existing Land Code Ordinance, Resolutions, and all future actions of the Shoshone Paiute Tribes of the Duck Valley Indian Reservation, Owyhee, Nevada, and is further subject to the following additional stipulations.

1. That I will farm this assignment in a manner, which will improve and preserve the soil, control and eradicate weeds and willows.
2. That I will maintain all farms, ditches, and structures contained within assigned land.
3. That I will make good and efficient use of the irrigation water and that I will comply with the provisions of the Code of Federal Regulations, Title 25, part 162.611.
4. That I will construct and maintain permanent improvements necessary to the operation of my assignment. Permanent improvements such as wells, irrigation structures, etc. shall become a part of the land, but all moveable improvements constructed by the assignee may be removed or sold at the option of the assignee. Except that such improvements must be disposed of within ninety (90) days after the termination of this assignment. Section 5 – Inheritance of Improvements, C., Land Code Ordinance 82-SPO-08.
5. Article VIII, Section 7, Constitution and By-Laws, *“The Business Council, if it sees fit, may charge a fee not to exceed \$5.00, on approval of an assignment made under this Section.”*
6. That I will not without prior approval of the Land Committee and Business Council by a duly adopted resolution, (a) lease or otherwise transfer the use of the assigned land, and (b) pasture livestock other than my own.
7. I agree that if any of the foregoing affirmations are false or if I fail to comply with the above stipulation pertaining to this assignment, it shall be revoked by the Business Council of the Shoshone-Paiute Tribes’ Land Code, Ordinance 82-SPO-08, Section 4, (A), 1, 2, 3, 4, and 5.
8. In the event of my death while enjoying the use and occupancy of this assignment, provided the assignment is in effect, I hereby designate, _____, who is related to me and is obligated to receive my assignment as the beneficiary of land assigned to me and covered by this application together with the improvements thereon. It is understood that the foregoing designation of a beneficiary may be changed by me at any time during my use and occupancy of the assignment, previous to any revocation of this assignment, filing a written notice in duplicate with the Business Council of the governing body of the Shoshone-Paiute Tribes of the Duck Valley Indian Reservation, a copy of which notice shall also be filed in the Tribal Land Office for record purposes.
9. I further understand that it shall be my responsibility to keep myself informed regarding the status of this application by checking with the Land Secretary periodically.
